AHFR is a ready for use product and may also be used as a spot cleaner on aircraft.

### DIRECTIONS FOR USE

- ▶ Spray the product on the surface to be cleaned
- ▶ Depending from the thickness of the hydraulic oil layer, let the product work for 1 to max 15 minutes.
- ▶ Rinse off with water

It is recommended to re-treat the complete aircraft afterwards with Ecosterile **Aircraft Cleaner**. This product will create an anti-static layer on the fuselage and reduce the adherence of hydraulic oil deposits in the future.
